

Software Only/No Equipment/No Furniture/No Gift Certificates

Revenue Share (must pay by ACH draft)

- Licensing Fee (River) 10% (RSS will collect and pay)
- RSS 20% / Customer 70%
- If sales exceed 20K for the month RSS increases 10%, customer gets 60% (60/40 over 20K).
- If customer bundles Jukebox, ATM, credit card service, they get 1% more (71%/29%).
- If customer contracts for Maverick, Phoenix, RimFire: 10% more license fee in invoices related to these 3 game systems (RSS will collect and pay).

Options for Upgrades

- 1. If RSS supplies and installs computers and electronic hardware, wiring, full tech support, replacement hardware, etc: 10% more.
- 2. If RSS supplies and installs furniture (Casino grade chairs counters): 5% more (3% Counters/2% Chairs)
- 3. If customer uses RSS product sale business model of gift certificates that provides opportunities for their customers to redeem music and other products (game play tap cards, vacation packages, boat charters, music, other products and services) from Lucky 7 Downloads website, which includes sales tax on redemption, the customer pays 6% more.
- 4. If customer does not pay by ACH draft, the customer pays 5% more.
- 5. If customer pays late, they will owe 10% late fee on past due amount.

Important Facts to Know

- 1. If a customer is not selling a product and giving away free sweeps points, this could be considered gambling. They should collect and pay sales tax for amusement services. See case TEXAS COURT OF APPEAL, THIRD DISTRICT, SIDETRACKED BAR LLC APPELLANT NO. 03-21-00335-CV. They also risk criminal consequences if accused of gambling (like all others doing this).
- 2. RSS will not provide any legal assistance or defense of any kind. It will provide legal support and expert witnesses if necessary regarding our game system. Customer should retain at all times local legal counsel at their own expense.
- 3. License fees are subject to sales tax. The revenue share gift certificates system (product based business model) is not subject to sales tax.
- 4. In all scenarios, customer is responsible to collect and pay sales tax (if any), except on music downloads and other products redeemed on the Lucky 7 Downloads website. It will state this in the contract, and customer will also have to sign a wholesale certificate form provided by State Comptroller.
- 5. RSS will not put more than 7-9 game terminals in a new customer unproven location. In a proven store we can do as high as 20, but over 20 will require President approval. We can always add more!
- 6. A software only customer can do whatever they want, such as "donation based" (which is subject to sales tax). They will be responsible for any wrongdoing. They cannot use our signs, rules, or any materials unless they operate properly and use our gift card system. They must make their own materials, as required by law.
- 7. RSS will provide a weekly text marketing program to all customers. Customer prizes for a monthly giveaway of \$1,000, Quarterly giveaway of a Mexico vacation for 2 people to Playa Del Carmen for 7 days, including airfare on Southwest Airlines (\$5k Value) and annual drawing for a recreation vehicle or prize chosen by company.
- 8. All customers who average or exceed \$240,000 per calendar year will receive a Mexico vacation for 2 people to Playa Del Carmen for 7 days, including airfare on Southwest Airlines (\$5k Value). Customers who average or exceed \$360,000 per calendar year will receive a vacation and an additional bonus prize with a value of more than \$10,000.
- 9. Donation Based Operators should plan to donate 5-10% minimum of gross to be paid to non-profit charity. In addition, they must also collect sales tax. This is the total responsibility of customer. SEE CASE TEXAS COURT OF APPEAL, THIRD DISTRICT, SIDETRACKED BAR LLC APPELLANT NO. 03-21-00335-CV.
- 10. If customer does not pay by ACH, they must adhere to company cash payment policy. If not strictly followed, they must pay 5% more on invoice.
 - Existing customers that want to switch to one of these options would have to purchase (all cash) our existing assets installed at their location related to FREE sweep games at our price.
 - \$2,000.00 per game station would include everything but server or pick & choose
 - Counters/Chairs \$500.00 per game station
 - Computers only \$1,500 per game station
 - \$1,800 removal fee minimum per system
 - Servers cannot be purchased
